Our Company, Promoter Selling Shareholder and Investor Selling Shareholder, in consultation with the Book Running Lead Managers, may offer a discount to the Offer Price to Eligible Employees Bidding under the Employee Reservation Portion ("Employee Discount") ("Net Offer"). The Company and the Selling Shareholders propose to undertake the Offer in compliance with Regulation 6(1) of the Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018, as amended (the "SEBI ICDR Regulations"), at such price as may be determined through the book building process, in accordance with the SEBI ICDR Regulations and pursuant to Rule 19(2)(b) of the Securities Contracts (Regulations) Rules, 1957, as amended (the "SCRR") read with Regulation 31 of the SEBI ICDR Regulations, the Companies Act, 2013, as amended, and other applicable laws. The Offer may also include allocation of Equity Shares to certain Anchor Investors, on a discretionary basis, by the Company, the Promoter Selling Shareholder, and the Investor Selling Shareholder in consultation with the BRLMs, in accordance with the SEBI ICDR Regulations. The Company, Promoter Selling Shareholder and Investor Selling Shareholder may, in consultation with the Book Running Lead Managers, consider a Pre-IPO Placement of such number of specified securities for cash consideration aggregating up to ₹480.00 million, prior to filing of the Red Herring Prospectus with the RoC. The Pre-IPO Placement, if undertaken, will be at a price to be decided by the Company, Promoter Selling Shareholder and Investor Selling Shareholder, in consultation with the Book Running Lead Managers. - 2. The Company and the Selling Shareholders have appointed Axis Capital Limited, ICICI Securities Limited, SBI Capital Markets Limited, and Anand Rathi Advisors Limited, as the book running lead managers to the Offer (the "BRLMs") to manage the Offer.
- 3. We are filing the draft red herring prospectus of the Company dated September 29, 2023 (the "**DRHP**") in relation to the Offer for your consideration and observations.
- 4. In connection with the filing of the DRHP with the Securities and Exchange Board of India (the "SEBI"), we hereby submit the following:
 - a. The soft copy of the DRHP in ".PDF" format signed and executed by (i) the directors of the Company ("Directors"); (ii) the Chief Financial Officer of the Company; and (iii) the Selling Shareholders, either themselves or through their authorised representative, as the case may be, approved by the board of directors of the Company in its meeting held on September 29, 2023 ("Annexure I"), accompanied by this letter and all annexures hereto, and shall be uploaded on the SEBI intermediary portal at https://siportal.sebi.gov.in and at cfddil@sebi.gov.in, as specified in Regulation 25(8) of the SEBI ICDR Regulations and chapter IV of the SEBI master circular no. SEBI/HO/CFD/PoD-2/P/CIR/2023/00094 dated June 21, 2023 read with the SEBI directive dated October 14, 2022 issued to the Association of Investment Bankers of India ("AIBI"). Furthermore, three physical copies of the DRHP, and one physical copy of the DRHP signed and executed by the Board of Directors, Chief Financial Officer and Selling Shareholders of the Company shall be filed with SEBI at SEBI Bhavan situated at Plot C4-A, G Block, Bandra Kurla Complex, Bandra (East), Mumbai 400 051, Maharashtra, India;
 - b. A certificate from the BRLMs in accordance with Regulation 25(2)(a) of the SEBI ICDR Regulations confirming that the Company, the Selling Shareholders, and the BRLMs have entered into an Offer Agreement dated September 29, 2023 (including the statement of *interse* allocation of responsibilities of the BRLMs), in accordance with Regulation 23(5) of the SEBI ICDR Regulations and the format specified in Schedule II of the SEBI ICDR Regulations (**Annexure II**);
 - c. A due-diligence certificate dated September 29, 2023, signed by the BRLMs, in accordance with Regulation 25(2)(b) of the SEBI ICDR Regulations (Annexure III), along with: (i) a due diligence process note as required under Form A of Schedule V of the SEBI ICDR Regulations (Annexure III A); and (ii) a detailed checklist indicating regulation wise compliance of the disclosures in the DRHP with the applicable provisions of the SEBI ICDR Regulations (Annexure III B), which is annexed to the due diligence certificate; and

1,332,000 for a total amount of ₹ 8,732,000 or amount mentioned in the challan generated on the SEBI's intermediary portal towards the filing fees for the DRHP as provided under Schedule III of the SEBI ICDR Regulations. The amount will be paid in the bank account number mentioned in the challan generated on the SEBI's intermediary portal, and the payment details will be subsequently intimated. As the Offer Price of the Equity Shares will be determined through the Book Building Process, we are unable to ascertain the actual size of the Offer at this stage. Accordingly, the filing fees is based on an estimated Offer size of up to ₹7,400 million, and the same should not be construed as the final Offer size for the purposes of Schedule XVI of the SEBI ICDR Regulations.

In connection with the Offer, please note the following:

A. Reservation and discount for eligible employees

Pursuant to Regulation 33 of the SEBI ICDR Regulations, certain Equity Shares in the Offer may be reserved for allocation and allotment on a proportionate basis to eligible employees of the Company ("Employee Reservation Portion"). The Employee Reservation Portion shall be finalized by the Company, the Promoter Selling Shareholder, and the Investor Selling Shareholder in consultation with the BRLMs prior to filing of the Red Herring Prospectus. Employee Reservation Portion shall not exceed 5% of the post-Offer paid up Equity Share capital of the Company, subject to compliance with Rule 19(2)(b) of the SCRR. Accordingly, the details of the Offer structure will be disclosed in the Red Herring Prospectus, post finalisation of reservation, if any.

Further, the Company through its Board or IPO Committee, as applicable, and the Promoter Selling Shareholder, and the Investor Selling Shareholder in consultation with the BRLMs, may consider providing a discount to the eligible employees Bidding in the Employee Reservation Portion, in accordance with the SEBI ICDR Regulations. Based on the decision of the Company, the Promoter Selling Shareholder, and the Investor Selling Shareholder in consultation with the BRLMs, the Employee Reservation Portion (if any) and the particulars of discount (if any) will be suitably updated in the Red Herring Prospectus and/or announced prior to the Bid/ Offer Opening Date in accordance with the provisions of the SEBI ICDR Regulations. In case a discount is offered, it will be suitably advertised along with Price Band and the minimum Bid Lot.

B. Pre-IPO Placement

The Company, in consultation with the BRLMs, may consider undertaking a Pre-IPO Placement aggregating up to ₹480.00 million, subject to obtaining appropriate approvals and corporate actions under applicable law and contractual obligations of the Company. The Pre-IPO Placement, if undertaken, will be at a price to be decided by the Company, in consultation with the BRLMs, and the Pre-IPO Placement will be completed prior to filing of the Red Herring Prospectus with the RoC. If the Pre-IPO Placement is undertaken, the amount raised from the Pre-IPO Placement will be reduced from the Fresh Issue, subject to compliance with Rule 19(2)(b) of the SCRR. Additionally, appropriate disclosures in relation to the Pre-IPO Placement, including in section



titled "Capital Structure" will also be updated in the Red Herring Prospectus pursuant to the Pre-IPO Placement, if it is undertaken. Upon completion of any pre-IPO Placement, the Company shall, inform the BSE Limited and National Stock Exchange of India Limited (the "Stock Exchanges") and make a public announcement in an English national daily newspaper, a Hindi national daily newspaper and a Telugu daily newspaper (Telugu being the regional language of Telangana, where the registered office of the Company is located), each with wide circulation, within such time and in such manner as prescribed by the SEBI.

C. Unified Payments Interface ("UPI")

Pursuant to SEBI circular SEBI/HO/CFD/TPD1/CIR/P/2023/140 dated August 9, 2023, the final reduced timeline of T+3 days using the UPI Mechanism for applications by UPI Bidders, has been notified and made effective on a voluntary basis for public issues opening on or after September 1, 2023, and on a mandatory basis for public issues opening on or after December 1, 2023.

The DRHP has been drafted in accordance with phase III of the UPI framework, subject to any circulars, clarifications, or notifications issued by the SEBI from time to time and also reflects additional measures for streamlining the process of initial public offers, as prescribed by SEBI in its circulars dated March 16, 2021, June 2, 2021 and April 20, 2022.

Accordingly, in accordance with the timelines mentioned above and any circulars, clarification or notification issued by the SEBI from time to time, the Company will suitably update the Red Herring Prospectus and the Prospectus.




